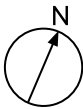

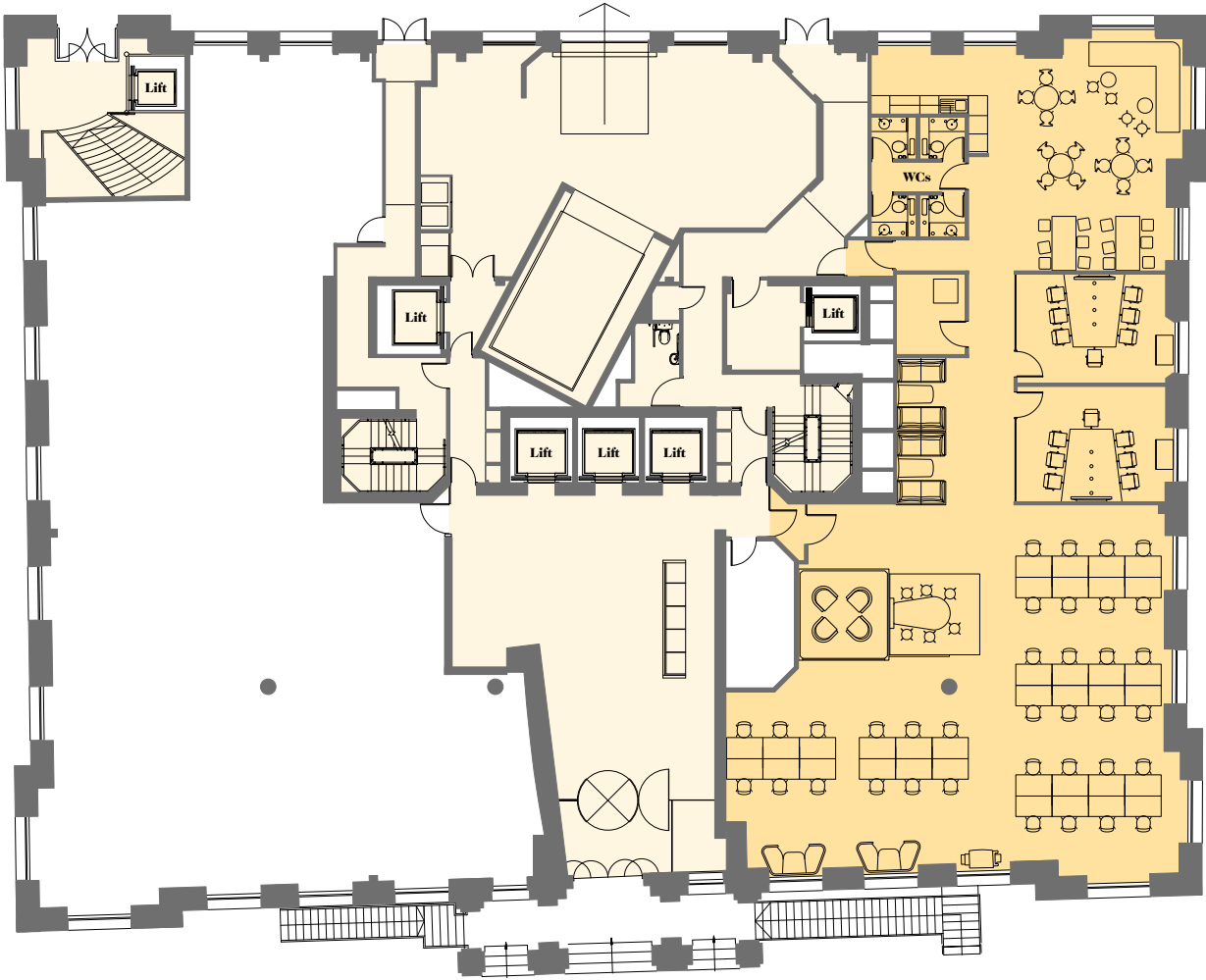

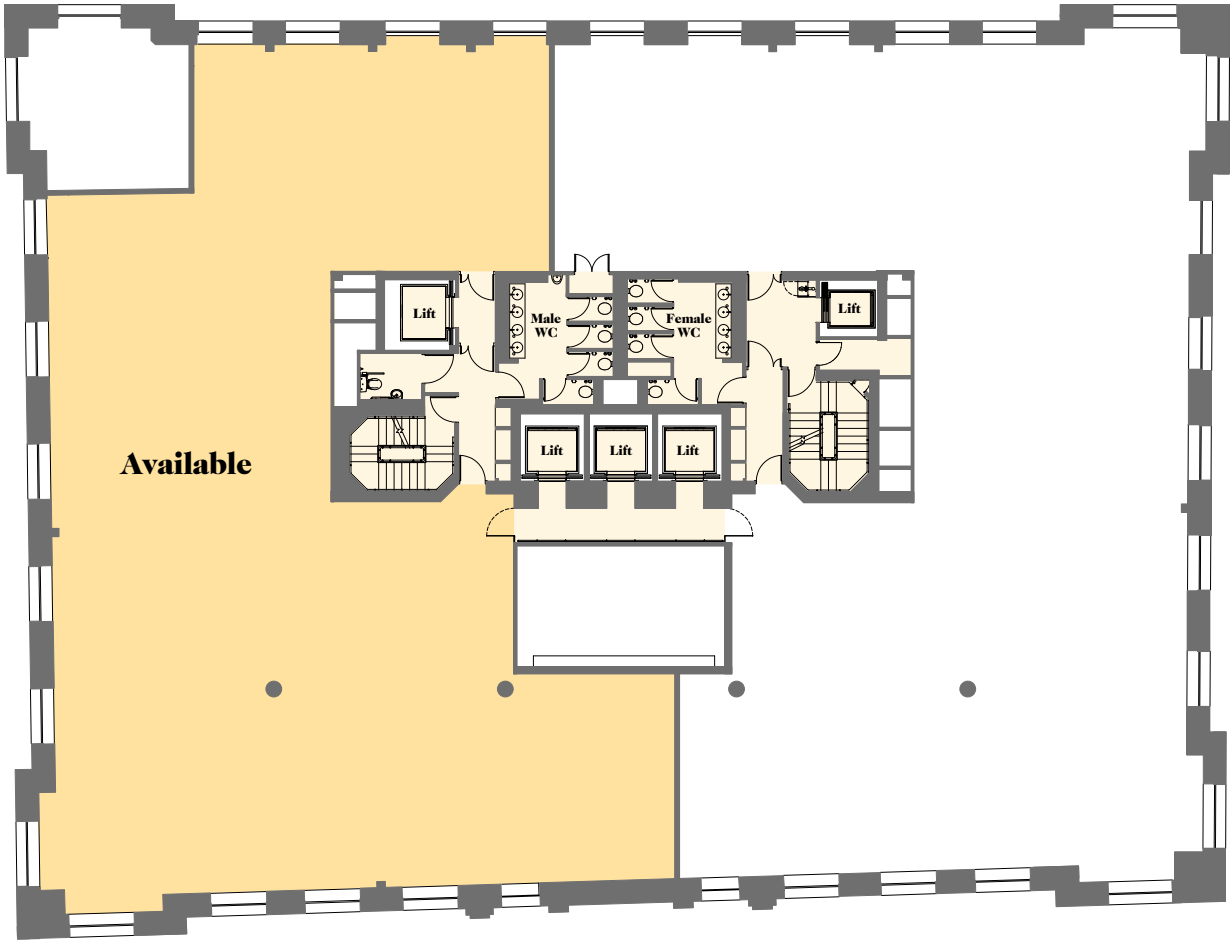

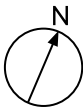
PART FIRST FLOOR

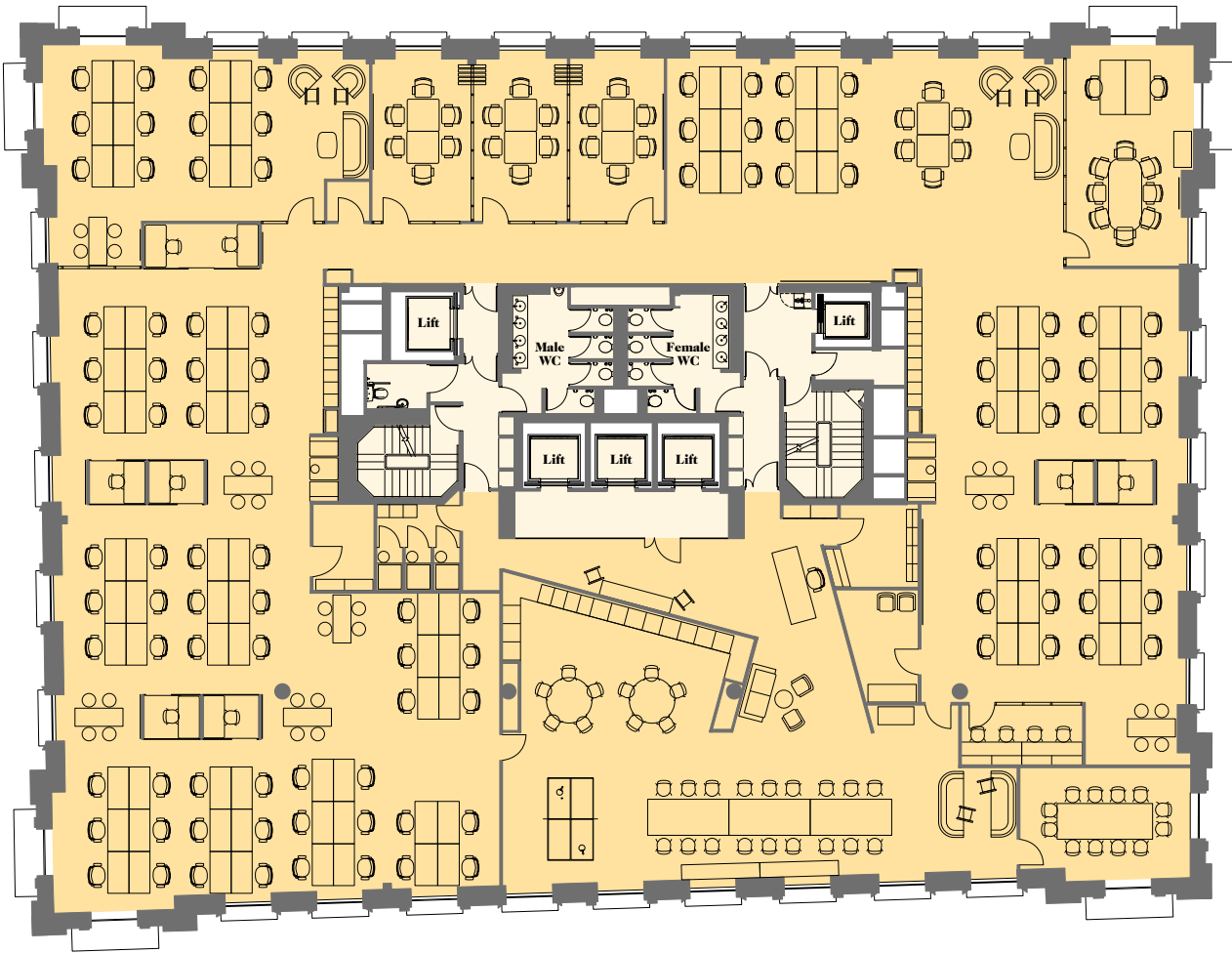

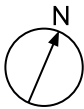
